Children's Party Package £17.95 per child

From 3rd November 2025 until 2nd April 2026

This package is suitable for groups of ten or more children aged three to eleven years old and includes entrance into the Leisure Park, party food and a ride on the dodgems*. For an additional £7.00 each, they can go bowling too.

With the party booking, two adults may enter the leisure park free of charge
(Usually the party organisers)

All other accompanying adult guests may enter at a reduced admission price of just £7.00 each.

Under 1's free of charge. Ages 1 & 2 we charge £5.00 each

Those children 2 and under can join in with the party food for £7.95 each.
Adults are also welcome to pre-order food from the day menu and dine with the party.

The party food is served with jugs of squash and you may choose any six items

Conditions of Business – Events, Functions & Conferences

Trethorne Leisure Park takes pride in offering excellent service and facilities to our guests, and agrees to provide the service and club facilities on the agreed function or event date.

In order to make it as easy as possible for all parties to work together, the following guidelines have been drawn up.

1. CONFIRMATION & DEPOSITS

When a provisional booking has been established, written confirmation is required within 14 days of the time of booking, together with a 25% deposit of the total amount due, agreed at the time of booking. If a booking is made within 6 weeks of the date of the function, the deposit becomes due immediately. Trethorne Leisure Park reserves the right to cancel any unsecured provisional booking not confirmed by the agreed date.

2. GUARANTEED NUMBERS FOR CATERING

Final numbers for attending a function must be notified at least 14 working days prior to the event. This is the Guaranteed Minimum Number. The charge to the client will be either the actual numbers attending, or the Guaranteed Minimum Number, whichever is the greater.

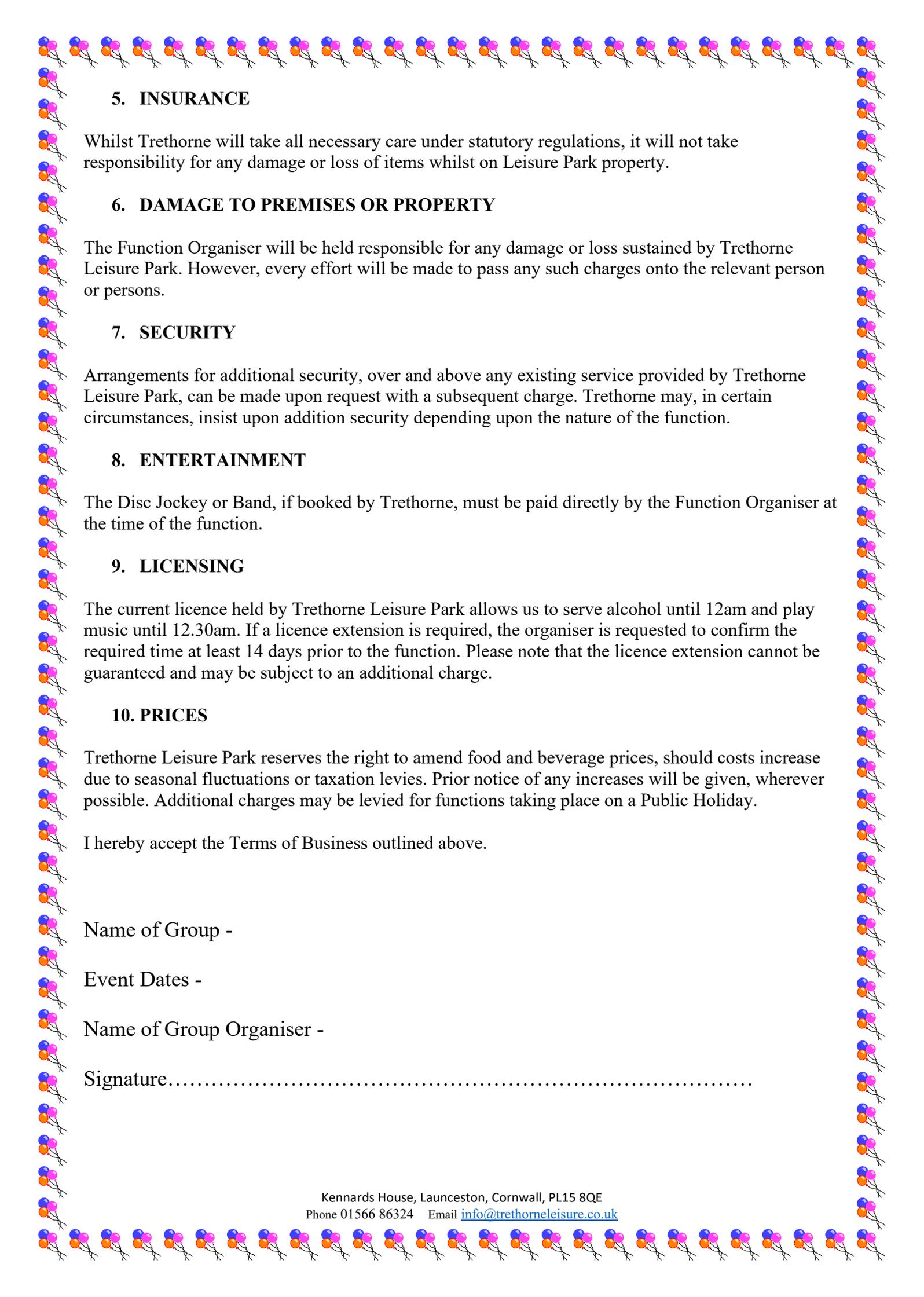
3. CANCELLATION

Although disappointed with the cancellation of any function, we realise that circumstances occasionally make this necessary. Any deposit paid is non-refundable. The event may be transferred to an alternative date if the cancellation is made at least 14 days prior to the function date. If the cancellation is made within 14 days of the function date, the business will be evaluated and an invoice for 50% of the lost revenue will be payable.

If in the event that Trethorne has to cancel or re-arrange the booking for any legitimate reason or due to unforeseen circumstances, all out of pocket expenses incurred by the customer will be fully reimbursed.

4. SETTLEMENT OF THE ACCOUNT

Unless credit facilities have been agreed prior to the function, the account must be settled 7 days prior to the event/function. Bar tabs will not be operated unless agreed prior to the function.



5. INSURANCE

Whilst Trethorne will take all necessary care under statutory regulations, it will not take responsibility for any damage or loss of items whilst on Leisure Park property.

6. DAMAGE TO PREMISES OR PROPERTY

The Function Organiser will be held responsible for any damage or loss sustained by Trethorne Leisure Park. However, every effort will be made to pass any such charges onto the relevant person or persons.

7. SECURITY

Arrangements for additional security, over and above any existing service provided by Trethorne Leisure Park, can be made upon request with a subsequent charge. Trethorne may, in certain circumstances, insist upon addition security depending upon the nature of the function.

8. ENTERTAINMENT

The Disc Jockey or Band, if booked by Trethorne, must be paid directly by the Function Organiser at the time of the function.

9. LICENSING

The current licence held by Trethorne Leisure Park allows us to serve alcohol until 12am and play music until 12.30am. If a licence extension is required, the organiser is requested to confirm the required time at least 14 days prior to the function. Please note that the licence extension cannot be guaranteed and may be subject to an additional charge.

10. PRICES

Trethorne Leisure Park reserves the right to amend food and beverage prices, should costs increase due to seasonal fluctuations or taxation levies. Prior notice of any increases will be given, wherever possible. Additional charges may be levied for functions taking place on a Public Holiday.
